

ElectroRoute Signs 15 Year route-to-market agreement with British Solar Renewables

- In a significant step towards strengthening the UK's clean energy system, ElectroRoute and British Solar Renewables (BSR) have signed a multi-year route-to-market agreement covering nine solar farms and delivering around-the-clock trading.

LONDON, 09 JULY 2025 - ElectroRoute, a leading energy trading and services company, has announced it has signed a 462 MWp capacity 15 year route-to-market agreement with British Solar Renewables, one of the UK's leading independent power producers.

The agreement covers nine of BSR's solar farms, collectively capable of generating approximately 482 GWh of clean electricity annually, producing enough energy to power approximately 130,000 homes each year. ElectroRoute will provide route-to-market services for the projects.

Tim Humpage, Chief Executive Officer of British Solar Renewables said: *"This agreement is another milestone in BSR's journey to becoming one of the UK's leading independent power producers. It supports our long-term strategy to develop, own, and operate high-quality renewable energy projects that deliver consistent value and impact. As we grow our operational portfolio, we remain focused on playing a meaningful role in strengthening the UK's energy resilience and accelerating the path to net zero."*

Caoimhe Giblin, co-CEO of ElectroRoute, commented on the landmark deal: *"This agreement with British Solar Renewables is a milestone for ElectroRoute, both in terms of scale and significance. It reflects our unwavering commitment to supporting the growth of renewable energy in Great Britain and demonstrates the trust placed in our expertise in energy trading and risk management. As we continue to expand our operations, partnerships like this are pivotal in enabling us to deliver on our ambition of driving the energy transition and helping the UK meet its net-zero targets."*

ElectroRoute will provide 24/7 trading services to optimise the output of BSR's solar farms, ensuring greater efficiency and stronger returns. The partnership reflects both companies' commitment to scaling clean energy with reliable, forward-thinking solutions.

For British Solar Renewables, the agreement is another step forward in its long-term mission to strengthen the UK's energy system through the development and ownership of high-quality renewable infrastructure. By securing a bankable route to market for a significant part of its operational portfolio, BSR continues to unlock investment at scale and support the UK's net zero transition.

The route-to-market agreement also marks a milestone for ElectroRoute, expanding its global portfolio to over 3GW across Great Britain, Ireland and Japan, and reinforcing its role as a key enabler in the clean energy transition.
